Welcome to jury service. In accordance with Idaho Code §2-206 a certified jury list has been created. You have been selected at random from the certified jury list to attend court as a prospective juror.

INSTRUCTIONS for the QUALIFICATION FORM

1. Fill out the back and return the Qualification Form within 10 days.

Any travel documentation or medical exemptions may be turned in, mailed or e-mailed to the Jury Commission at a later date.

GENERAL INFORMATION

1. Parents / Guardians may include pertinent information for a child who is away, please write your comments on the qualification form in the box outlined in red.

A potential juror may be postponed but is not removed until credible documentation is received.

2. **Have you moved from Bingham County?** Please provide a copy of an updated driver's license, a copy of the **1st page** of a rental or mortgage agreement, or a copy of your voter's registration card.

3. A Summons will be mailed telling you the date, time and courtroom to appear. As a courtesy, you will only receive a text message if you have opted in and the trial you have been selected for is going forward. Provide your wireless provider to ensure our computer program can send you the text message. It is your responsibility, as a potential juror, to be aware of the dates and times of your Summons.

4. Your term is for four (4) months. During that time you may receive one to four summonses.

5. Be on time and allow the entire day for your jury service.

6. Dress appropriately; nice, neat and clean. Uniforms or logo attire are not acceptable.

Keep track of the items you bring into the Courthouse, many times, they are left behind.

7. You may stand to relieve back discomfort. When you check in, please inform the bailiff.

8. If you serve as a juror, it is customary to be released for the remainder of your term.

POSTPONEMENTS

Any person requesting a postponement needs to provide a written statement explaining the reason for the request and the anticipated date that the reason will no longer exist. Documentation is required. All requests and documentation will be kept on file and all requested exemptions will be determined by the administrative district judge **after a potential qualified juror receives their Summons.** Children and/or work are not usually an excuse from jury service.

Often citizens express that serving on jury duty creates difficulties and inconveniences for them. We recognize your concerns. Your public service as a juror protects our right to have a trial by an impartial jury. Your participation is vital and your contribution to this important process is appreciated.
